

Waste Management Fees - Decree No. 113 of 2022



Overview

On 19 June 2022, Decree no. 113 of 2022 was issued by the Minister of Environment in application of the Waste Management Law no. 202 of 2020 to specify the fees for issuing the licenses and approvals for waste management activities (the "**Decree**"). The Decree was circulated in the Official Gazette on 24 August 2022.

Highlights

- The Decree includes three fee schedules for waste management licenses and approvals, as follows:
 - a- The license fees for non-hazardous waste management activities (collection and transportation, treatment plants and sanitary landfills);
 - b- The approval fees and categories regarding the circulation of hazardous waste and materials; and
 - c- The permit fees for the import of hazardous waste and materials.

It is worth noting that the aforementioned fees are separate to VAT payment.

- The Waste Management Regulatory Authority (the "WMRA") shall receive 0.5% of each municipal waste management contract entered into by the competent administrative authorities in return for the technical reports evaluating the performance of the relevant service providers in the implementation of the administrative contracts.
 - The collection of such amounts shall begin one year from the Decree's entry into force.
- The proceeds of the amounts prescribed in the Decree shall be transferred to the WMRA's account, and the value-added tax shall be transferred to the Tax Authority.

Schedule 2 – Circulation of Hazardous Waste and Materials

1.	Issuing an approval for the transportation of hazardous waste and materials in one governorate.	EGP 20,000 for issuance of the approval. EGP 10,000 for the withdrawal of approval and requesting re-issuance.
2.	Issuing an approval for the transportation of hazardous waste and materials in five governorates.	EGP 40,000 for issuance of the approval. EGP 20,000 upon thewithdrawal of approval and requesting re-issuance.
3.	Issuing an approval for the transportation of hazardous waste and materials across the country.	EGP 60,000 for issuance of the approval. EGP 30,000 for the withdrawal of approval and requesting re-issuance.
4.	Issuing an approval for the storage of hazardous waste and materials.	EGP 35 per square meter. EGP 20 per square meter for the withdrawal of the approval and requesting re-issuance.
5.	Issuing an approval for the treatment of hazardous waste and materials.	EGP 30,000 for issuance of the approval. EGP 15,000 for the withdrawal of the approval and requesting re-issuance.
6.	Issuing an approval for safe disposal of hazardous waste and materials (establishing a sanitary landfill for hazardous waste).	EGP 200,000 for issuance of the approval. EGP 180,000 on the withdrawal of athe pproval and requesting re-issuance.

Schedule 3 – Hazardous Waste Import Approval

No.	Type of permit or service	Fee for issuance
1.	Issuing one-year permits for the import of hazardous waste as a production requirement.	1% of the value of the permitted annual import amount, not exceeding the legal limit of EGP 200,000.
2.	Issuance of import permits for hazardous materials.	1% of the value of the permitted annual import amount, not exceeding the legal limit of EGP 200,000.
3.	Issuance of a notification of approval in relation to: the import of non-hazardous waste through the Basel Convention and export and transit of hazardous waste through the Basel Convention.	EGP 3,000 per notification.
